## SECTION 4 - FIRST AID MEASURES

---

**General Advice:** In case of accident or if you feel unwell, seek medical advice immediately. When symptoms persist or in all cases of doubt seek medical advice.

**If Inhaled:** If inhaled, remove to fresh air. Get medical attention if symptoms occur.

**Extinguishing media:** Water spray, alcohol-resistant foam, dry chemical, carbon dioxide (CO<sub>2</sub>)

**Unsuitable extinguishing media:** High volume water jet

**Specific hazards during fire fighting:** Do not use a solid water stream as it may scatter and spread fire. Exposure to combustion products may be hazardous to health.

**Hazardous combustion products:** Carbon oxides

**Specific extinguishing methods:** Use extinguishing measures that are appropriate to local circumstances and the surrounding environment. Use water spray to cool unopened containers. Remove undamaged containers from fire area if it is safe to do so. Evacuate area.

## SECTION 6 - ACCIDENTAL RELEASE MEASURES

---

**Personal precautions:** Remove all sources of ignition. Ensure clean-up is conducted by trained personnel only. Refer to protective measures listed in sections 7 and 8.

**Environmental precautions:** Do not allow contact with soil, surface or ground water.

**Containment and cleanup:** Eliminate all ignition sources if safe to do so. Stop leak if safe to do so. Contain spillage, and then collect with non-combustible absorbent material, (eg, sand, earth, vermiculate) and place in container for disposal according to local/national regulations (see section 13). Flush away traces with water. For large spills, dike spilled material or otherwise contain material to ensure runoff does not reach a waterway.

## SECTION 7 - HANDLING AND STORAGE

---

**Advice on safe handling:** Take necessary action to avoid static electrical discharge (which might cause ignition of organic vapors). Keep away from fire, sparks and heated surfaces.

**Conditions for safe storage:** Keep away from heat and sources of ignition. Keep in a cool, well-ventilated place. Keep away from oxidizing agents. Keep out of reach of children. Keep containers closed and sealed. Store in suitably labeled containers.

**Storage temperature:** 0 C to 35 C (32 F to 95 F)
