**Product Description:** This is an FDA-compliant non-drug personal care product intended for application to human skin for the purpose of repelling insects. It is safe for external use for healthy individuals when used as directed. Not intended for children under 6 months of age.

**Recommended Use:** As a spray for repelling flies and mosquitos and other common outdoor pests that are attracted to human skin.

**Restrictions on Use:** This is a personal care product that is safe for consumers when used as indicated. The purpose of this SDS is to provide safety information for consumers using the product and workers handling the product in bulk. This product may present hazards to both consumers and industrial handlers. This SDS should be retained and available for employees and other industrial handlers of this product. This product is not intended for children under the age of 6 months without a physicians recommendation. It is not intended to be used on diseased, damaged or broken skin. This product contains 50% alcohol and will support combustion. Care must be taken around campfires, and other sources of ignition by consumers when the product has been applied and is still wet. Once the product dries on the skin it is no longer a flammability risk. Industrial users must be careful not to expose the product to ignition sources and if the product has spilled on the ground, care must be taken to avoid fire.

## SECTION 4 - FIRST AID MEASURES

---

**General Advice:** In case of accident or if you feel unwell, seek medical advice immediately. When symptoms persist or in all cases of doubt seek medical advice.

**Extinguishing media:** Water spray, alcohol-resistant foam, dry chemical, carbon dioxide (CO2)

**Unsuitable extinguishing media:** High volume water jet

**Specific hazards during fire fighting:** Do not use a solid water stream as it may scatter and spread fire. Exposure to combustion products may be hazardous to health.

**Hazardous combustion products:** Carbon oxides

**Specific extinguishing methods:** Use extinguishing measures that are appropriate to local circumstances and the surrounding environment. Use water spray to cool unopened containers. Remove undamaged containers from fire area if it is safe to do so. Evacuate area.

**Personal precautions:** Remove all sources of ignition. Ensure clean-up is conducted by trained personnel only. Refer to protective measures listed in sections 7 and 8.

**Environmental precautions:** Do not allow contact with soil, surface or ground water.

**Containment and cleanup:** Eliminate all ignition sources if safe to do so. Stop leak if safe to do so. Contain spillage, and then collect with non-combustible absorbent material, (eg, sand, earth, vermiculate) and place in container for disposal according to local/national regulations (see section 13). Flush away traces with water. For large spills, dike spilled material or otherwise contain material to ensure runoff does not reach a waterway.
